2010 - 2011 PROGRAM

The center will be open Monday through Friday, 7:00 am to 6:00 pm with full time and part time schedules offered five days, three days (Monday, Wednesday, and Friday), or two days (Tuesday, Thursday) per week.

Children must be two years old and able to toilet independently upon entering the program. Children can remain in the program until they enter Kindergarten.

There is an annual registration fee of \$150.00.

Lunch Bunch (12:00 p.m. - 1:00 p.m.) -----\$ 4.00 per day paid in advance

The 2010 - 2011 school year begins September 1, 2010 and concludes June 17, 2011. The tuition fees for part time and full time schedules are based on a whole school year cost, divided into 10 equal monthly payments, September 2010 through June 2011. The summer program is a separate weekly charge.

Additional hours may be added to the part-time schedule. The charge for extra hours is \$4.00 per hour. If you need this on a consistent weekly basis, the preschool office will calculate a monthly fee for you. Occasional use of additional hours may also be arranged for your child. We ask for a one-week notice to enable us to accommodate your request.

You have the opportunity for your child to stay now and then for the lunch hour (Lunch Bunch 12:00 p.m. - 1:00 p.m.). You will need to provide a sack lunch for your child. We need at least a one-day notice. Lunch bunch and additional hours are granted only if there is space to stay within the required adult/child ratio.

The registration fee and the first month's tuition are due to Christ Lutheran Preschool upon enrollment of your child. The registration fee is non-refundable.

Payments received after the 10th of the month will be assessed a late fee of \$25.00 or 5%, whichever is greater. A fee of \$25 will be assessed for returned checks. The summer program is a separate weekly charge. Summer enrollment forms are distributed in the beginning of May each year.

Our center closes at 6:00 p.m. each day. A late fee of \$1.00 for each minute will be assessed - per child - if the child is picked up after the 6:00 p.m. closing time.

Full time (five days per week and twelve months) families will not be required to pay for vacation time taken, up to two weeks per calendar year. Vacation time must be taken in full-week increments for this policy to apply. Vacation credit **will not be given** during times when the preschool is scheduled to be closed. **Before one year of attendance**, all vacation time must be paid in order to hold your child's place.

**We require a two week written notice
for any changes in your child's schedule.**
